



Stupendous! Micro-Chimerism

Micro-chimerism occurs when the cells of the baby in utero migrate into the mother's bloodstream and then circle back into the baby. During pregnancy the cells circulate and merge backwards and forwards, and after the baby is born, many of these cells stay in the mother's body, leaving a permanent imprint in the mother's tissues, bones, brain, and skin. Every single child a mother has afterwards leaves a similar imprint on her body, as well. Even if a pregnancy doesn't go full term or if there is a miscarriage these cells still migrate into the bloodstream.

Research has confirmed that fetal cells will rush to the site of a mother's injured heart, for example, and mutate into cells which will heal the injury. The baby helps repair the mother while

the mother builds the baby. This explains why certain illnesses vanish in pregnant women. The mother's body protects the baby and the baby protects and rebuilds the mother in turn so that the baby matures.

Studies have also shown that fetal cells have persisted in a mother's brain 18 years after she gave birth! Amazing! This phenomenon is recognized as fetal-maternal micro-chimerism which is the presence of more than one set of genes in the bloodstream or in other tissues and organs.

The State of Assisted Suicide in Canada

5th Annual Report on Medical Assistance in Dying in Canada

On December 11, Canada's Ministry of Health released the Fifth Annual Report on Medical Assistance in Dying in Canada 2023, which indicated that there were 15,343 reported euthanasia deaths in 2023 representing **4.7% of all deaths**. There have been **60,301 Canadian euthanasia deaths since legalization** (June 2016 to December 31, 2023) and now there has likely been more than 75,000 Canadian euthanasia deaths. This number represents more than every single person living in Cornwall, Alexandria, Lancaster and Long Sault!!

There is specific concern related to the number, growth and types of euthanasia deaths in Québec, Ontario and British Columbia. Further concerns include the fact that in 2023:

- 1,392 of the euthanasia deaths listed "frailty" as a reason.
- 933 listed chronic pain as a reason.
- 241 listed dementia as a reason.

One hundred and six cases listed dementia as the only reason, even though the law does not permit euthanasia for dementia alone. Another concern is with the "other conditions" category. The report indicated that when a person with disabilities died based on a Track 1 approval (the person is considered terminally ill), 46.2% of those deaths were based on "other conditions" and when it was a Track 2 approval (the person is not considered terminally ill), 62.9% of those deaths were based on "other conditions". Canada's euthanasia law does not define "other conditions".

A University of Toronto professor of psychiatry told CTV News that, according to the report, there was likely at least 622 euthanasia deaths that were non-compliant with the law.

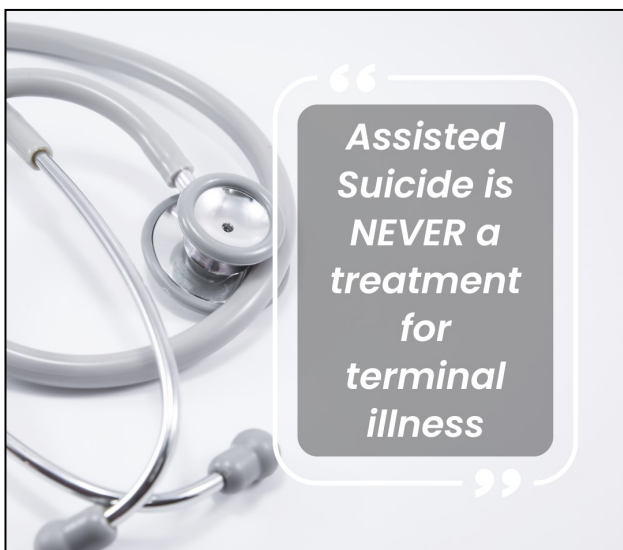

"At the age of 46, our only daughter was diagnosed with a stage 4 sarcoma. At the age of 48, after unsuccessful treatments in Canada, the United States and Mexico, with death at her doorstep, she chose euthanasia. These poems were written after our grief counsellor suggested that writing would help us cope with our complex grief. My wife wrote the single poem 'Timeline for an Execution'. This inspired me to change the focus of my writing from poems about my daughter's cancer which I was working on to poems about the murderous execution that euthanasia is."



The following are some of these poems crafted in pain and anguish. If they deter even a single person from choosing euthanasia/assisted suicide, they will have served their purpose.

I also hope that any person considering witnessing the actual moment that the deadly liquid enters their loved one's body choose not to do so as this will leave them with deep psychological scars which they will carry to the grave with them. Remember, you are choosing to witness a murder; nevertheless, had I not made a mistake by witnessing the event to its conclusion, I would not have been able to write these poems, which I hope will give people around the world a clearer picture of the nature of euthanasia, from beginning to end."
